We received your e-mail and you are to receive your payment as soon as possible.

Your fund was long with-held due to improper and un-official payment documentations, lack of proper verification documents from the beneficiary to ascertain the legality, source/origin and authenticity of these funds. As a means of boosting the ailing world economy thereby making funds and cash readily available and to ease credit facilities, these funds have now been properly documented and verified officially by the various government authorities involved and we have been asked by the these government authorities involved together with the United Nations authority to urgently expedite action and get the fund immediately released to the beneficiary as your name appears on the payment list. The various government authorities involved have done and completed all the necessary documentations, obtained the needed approval and have obtained all needed legal papers backing the legal release of the fund to you without delay based on the simple fact that the fund is in your name. Upon receiving the fee, your fund shall be released to you within hours. (Also scan and forward to us, the Western Union Receipt or the Money Gram Receipt for official files and records purpose).

Fund Payment Release Affidavit

AT THE INTERNATIONAL COURT OF JUSTICE, HAGUE NETHERLANDS

1. THAT RON [REDACTED] IS DUE TO RECEIVE THE FUND AMOUNTING TO US\$ 4.5 MILLION AS LISTED IN THE PAYMENT FILE OF THE FEDERAL RESERVE BANK NEW YORK US
2. THAT RON [REDACTED] IS A BONAFIDE BENEFICIARY OF THE SAID FUND WHICH HAS BEEN IN HIS/HER NAME ACCORDING TO THE PAYMENT FILES AND RECORDS AVAILABLE.
3. THAT THE G8 GOVERNMENT, UNITED NATIONS GOVERNMENT AND THE UNITED STATES GOVERNMENT HAVE JOINTLY AND UNANIMOUSLY APPROVED THE IMMEDIATE PAYMENT OF THE SAID FUND - US\$ 4.5 MILLION TO THE BENEFICIARY - RON [REDACTED] WITH IMMEDIATE EFFECT AND WITHOUT DELAY IN LINE WITH DUE PROCESS.
3. THAT RON [REDACTED] ENTITLED TO CLAIM RECEIVE THE FUND AS STATED IN THE WITH THE PAYMENT PROCEDURES AND DUE PROCESS AS WILL BE DETERMINED BY THE FEDERAL RESERVE BANK NEW YORK. THE BENEFICIARY RON [REDACTED] WILL ADHERE STRICTLY AND FOLLOW THE SAID GUIDELINES AS WILL BE INFORMED IN LINE WITH THE DUE PROCESS FOR THE IMMEDIATE PAYMENT OF FUND.

THAT A MEMORANDUM OF UNDERSTANDING (MOUT) WAS SIGNED BY THE BOARD OF DIRECTORS OF THE FEDERAL RESERVE BANK NEW YORK AND THE G8 GOVERNMENT, UNITED NATIONS GOVERNMENT AND THE UNITED STATES GOVERNMENT HEREBY AUTHORIZING THE IMMEDIATE PAYMENT AS SOON AS POSSIBLE IN COMPLIANCE WITH THE DUE PROCESS.

THIS AFFIDAVIT IS SWORN AND MADE IN GOOD FAITH AND FOR RECORD PURPOSES AND IN ACCORDANCE WITH THE OATHS ACT LAWS OF THE INTERNATIONAL COURT OF JUSTICE, THE HAGUE NETHERLANDS.
