ARRC Announces Federal Reserve Open Office Hours on Transition from LIBOR (Updated from February 12, 2019)*

****This release was initially issued on February 12, 2019 and was updated on February 26, 2019. The format of the call has been adjusted to take place in "listen-only" mode and requires questions to be submitted in advance (details below). The dial-in for the call has also been updated.***

Weekly Conference Call Provides Market Participants with Regular Opportunities to Ask Questions on Key Transition Issues

The Alternative Reference Rates Committee (ARRC) announced that David Bowman, Senior Advisor at the Board of Governors of the Federal Reserve, will hold weekly open office hours. On Friday afternoons, David will host a weekly conference call to answer questions about the transition from LIBOR from the perspective of Federal Reserve Board staff. The Federal Reserve Board is a convener of the ARRC, along with the Federal Reserve Bank of New York.

These office hours are intended for market participants and are not for the press, who should instead contact [Andrew S. These questions will then be addressed during the office hours, and will be read without the name or affiliation of the questioner mentioned.**

About the ARRC

The ARRC is a group of private-market participants convened by the Federal Reserve Board and Federal Reserve Bank of New York in cooperation with the Bureau of Consumer Financial Protection, the Federal Deposit Insurance Corporation, the Federal Housing Finance Agency, the Office of Financial Research, the Office of the Comptroller of the Currency, the Commodity Futures Trading Commission, the Securities and Exchange Commission and the U.S. Treasury Department. It was initially convened in 2014 to identify risk-free alternative reference rates for USD LIBOR, identify best practices for contract robustness, and create an implementation plan with metrics of success and a timeline to support an orderly adoption. The ARRC accomplished its first set of objectives and identified SOFR as the rate that represents best practice for use in certain new USD derivatives and other financial contracts. It also published its [Paced Transition Plan](#), with specific steps and timelines designed to encourage adoption of SOFR. The ARRC was reconstituted in 2018 with an expanded membership to help to ensure the successful implementation of the [Paced Transition Plan](#), address the increased risk that LIBOR may not
