David Erickson, FRBNY's Head of Outreach & Education, called the meeting to order at 2:15pm during the 2025 Annual Conference of Second District Directors and Advisors.

### 1. Welcome

Mr. Erickson greeted members and welcomed former CAG members who were present at this meeting as part of the 2025 Annual Conference of Second District Directors and Advisors.

Mr. Erickson also welcomed the newest member of the CAG, Beth Gosch, Executive Director of the Western New York Foundation.

### 2. Roundtable Discussion with CAG Members and Alumni

Members participated in a roundtable discussion on economic conditions, including opportunities and challenges faced by communities in the district. Members discussed broad uncertainty and reorganizations in the nonprofit sector amidst federal policy changes and trends in philanthropy. Members leading funding organizations stated that they are seeing more requests from grantees for additional funding than they could support, and noted that increases in foundation tax rates could cut disbursements to communities.

John C. Williams, FRBNY President and CEO, joined the discussion from 2:30pm-2:50pm. Members shared that their organizations were in worse economic and financial positions now relative to the last CAG meeting in March 2025. Several members noted that they had received DOGE inquiries, and that numerous partner programs at federal agencies had been cut. Members shared that regions reliant on Canadian commerce are seeing pullbacks in cross-border economic engagement. Members also noted that tariffs have driven cost increases, and changes at the Department of Housing and Urban Development have aggravated challenges in the affordable housing sector. Members whose organizations serve immigrant communities shared that they have seen retrenchment from service engagement amidst increased federal enforcement. Lastly members shared that while inflation is easing in certain communities, stakeholders are fearful of diminishing philanthropic resources and strained relationships between corporates and nonprofits.

# 3. Closing

Following the discussion, Mr. Erickson thanked members for their participation.
