December 2010	FR Y-6 <ul style="list-style-type: none">• Revised the reporting instructions for Report Item 2(b): Domestic Branch Listing to include where the branch report can be downloaded when it is available
December 2009	<ul style="list-style-type: none">• Clarified the general instruction for the audit requirements when total assets of an institution are measured for the annual audit requirement• Revised the general instructions to extend the deadline for completion of the annual audit requirement for nonpublic companies, as amended by part 363 of FDICIA 111• Clarified the general instructions to explain the legal responsibilities of the person attesting to the validity of the report• Revised the instructions for Report Item 2(a) to reference the accounting standard (FAS 167), with respect to the exclusion of reporting of variable interest entities (footnote 4)• Clarified the instructions for Report Item 3: Securities holders, with respect to warrants issued by the Treasury through the TARP CCP program that are convertible into common stock.

- Added to the cover page a requirement for the reporter to certify that they have the authority to provide to the Federal Reserve the information requested for individuals; and the authority, on behalf of each individual, to consent or object to public release of information regarding that individual
- Added verbiage to the confidentiality section in the general instructions to explain that the reporter is responsible for ensuring that the information provided on individuals is limited to that which is requested in the relevant report items; and to explain that the reporter must take the appropriate measures to safeguard the confidentiality of information provided to the Federal reserve, including information regarding individuals

December 2006

- Revised the attestation statement on the cover page
- Added the requirement for BHCs to provide their public web address on the cover page
- Added a section to the cover page to indicate if confidentiality has been requested
- Added the exemption from reporting public welfare investments under certain conditions
- Added the definition for "Company"

December 2004

- Revised the reporting requirement so that only top-tier bank holding companies file the FR Y-6
- Added two new items to the cover page
- Revised the certification section on the cover page
- Eliminated the requirement that a top-tier bank holding company submit a copy of its SEC Form 10K
