# Responses to Survey of Market Participants Distributed: 07/14/2016 – Received by: 07/18/2016

For most questions, median responses across respondents, along with the 25<sup>th</sup> and 75<sup>th</sup> percentiles, are reported. For questions that ask respondents to give a probability distribution, the average response across respondents for each potential outcome is reported.<sup>1</sup> Brief summaries of the comments received in free response form are also provided.

Responses were received from 29 respondents. **Except where noted, all 29 respondents responded to each question.** In some cases, respondents may not have provided forecasts extending to the same time horizon as requested in the survey. In these instances, the number of respondents who answered all parts of the question is indicated.

### **Monetary Policy Expectations**

1. Provide below your expectations for changes, if any, to the language referencing each of the following topics in the July FOMC statement.

### Current economic conditions: (28 responses)

Some respondents expected the Committee to note continued improvement in the labor market. Furthermore, several participants expected the Committee to note an improvement in economic activity, and several expected that the July FOMC statement would reference growth in consumer spending. Additionally, several respondents indicated that they expected no significant changes to the Committee's communication on current economic conditions in the July FOMC statement.

### Economic outlook: (28 responses)

Some respondents indicated that they expected no significant changes to the Committee's communication on the economic outlook in the July FOMC statement. Several other participants noted that they expected the Committee to indicate that uncertainty regarding the economic outlook remains elevated.

Communication on the expected path of policy rates and forward guidance on the target federal funds rate:

(27 responses)

Many respondents expected no change in the Committee's communication on the expected path of policy rates and forward guidance on the target federal funds rate in the July FOMC statement.

Communication on the Committee's policy of reinvesting principal payments on Treasury and agency securities:

(26 responses)

All respondents that submitted responses to this question expected no change in the Committee's communication on its policy of reinvesting principal payments on Treasury and agency securities.

Please Explain: (26 responses)

In explaining their rating, several respondents cited some difficulty in interpreting the variety of views expressed by FOMC participants since the June FOMC meeting, while several respondents interpreted the Committee's communications as consistently emphasizing a gradual approach to further policy normalization. Additionally, several respondents cited a lack of clarity regarding the drivers of declines in FOMC participants' year-end rate projections in the June SEP.

(22 responses)

Several respondents indicated that they revised their expected path of policy following FOMC communication, including the decline in FOMC participants' projections of the target federal funds rate in the June SEP. Additionally, several respondents indicated that they perceived the likely path of monetary policy as being flatter than in the last policy survey due to global developments, including central bank actions and the U.K. referendum, with several respondents noting uncertainties related to the impact of the U.K. referendum as having driven changes in their expectations. Lastly, several respondents noted that their expectations had not changed materially since the last policy survey.

Several respondents cited an expected increase in trend GDP growth as a major factor underlying their expectation for changes to the levels of the neutral real federal funds rate over time. In addition, several respondents cited an expected increase in productivity growth and a dissipation of global financial headwinds as major factors underlying their expectations for changes to the levels of the neutral real federal funds rate over time.

Please explain any changes to your estimates since the last time this set of questions was asked on October 19. (24 responses)

In explaining changes to their estimates, several respondents cited structural factors such as headwinds associated with labor force dynamics and global economic growth. In addition, several respondents cited changes to expected economic or potential economic growth as underlying the changes to their estimates. Lastly, several respondents noted that they made no significant changes to their estimates since the last time the question was asked on October 19.
