The **Survey of Market Participants** is formulated by the Trading Desk at the Federal Reserve Bank of New York to enhance policymakers' understanding of market expectations on a variety of topics related to the economy, monetary policy and financial markets. The questions involve only topics that are widely discussed in the public domain and never presume any particular policy action. FOMC participants are not involved in the survey's design.

For most questions, median responses across dealers, along with the 25th and 75th percentiles, are reported.¹ For questions that ask respondents to give a probability distribution, the average response across respondents for each potential outcome is reported. Brief summaries of the comments received in free response form are also provided.

Responses were received from 27 respondents. Except where noted, all 27 respondents responded to each question. In some cases, respondents may not have provided forecasts extending to the same time horizon as requested in the survey. In these instances, the number of respondents who answered all parts of the question is indicated.

Current economic conditions:

Several respondents indicated that they expected no or few significant changes to the Committee's assessment of current economic conditions in the May FOMC statement. Several respondents suggested that the Committee could acknowledge that economic activity had expanded at a slower pace during the first quarter of 2017, while several indicated that the Committee could attribute this to transitory factors. Several respondents also noted that the Committee would likely acknowledge the recent decline in the unemployment rate. Lastly, several respondents noted that they expected the Committee to acknowledge an improvement in business fixed investment.

Economic outlook: (25 responses)

Many respondents noted that they expected no or few significant changes to the Committee's language on the economic outlook.

Communication on the expected path of the policy rate and forward guidance on the target federal funds rate:

Many respondents noted that they expected no change in the Committee's communication on the expected path of the policy rate and forward guidance on the target federal funds rate.

Communication on the Committee's policy of reinvesting principal payments on Treasury and agency securities:

(26 responses)

Many respondents noted that they expected no change in the Committee's communication on its policy of reinvesting principal payments on Treasury and agency securities. Several respondents indicated that the Committee might acknowledge that a change to reinvestment policy could occur later this year.

Respondents did not provide substantial commentary in this section.

Please explain: (22 responses)

Several respondents indicated that recent communication from Federal Reserve officials regarding the outlook for balance sheet normalization had generally been clear and effective. Several other respondents suggested that communication on this topic had not been been effective, with several specifically noting a lack of clarity regarding policymakers' views on changes to reinvestment policy as potential substitutes for policy rate increases.

Several respondents reported that they adjusted their expectations for the timing and/or pace of future target rate hikes in response to changes to their expectations for reinvestment policy and/or recent Federal Reserve communication. Several respondents reported that there were no or few significant changes to their responses since the last policy survey.

Several respondents indicated that the Committee could phase out reinvestments by lowering the proportion of principal payments reinvested each month, while several others indicated that they expect the amount of principal payments reinvested to be reduced by a fixed dollar amount each month. Lastly, several respondents indicated that they expect the Committee to pursue the same strategy of phasing out reinvestments for both Treasury and agency securities, while several indicated that the Committee could pursue different strategies. 6e-i) Please indicate the percent chance that you attach to the following possible outcomes for the par value of the SOMA portfolio <u>at the end of 2019</u>, <u>conditional on not moving to the ZLB at any point</u> between now and the end of 2019. However, several respondents noted that they either moved earlier their modal forecast for the timing of when the Committee announces a change to its reinvestment policy or assigned a greater probability to a change occurring in 2017, with several citing recent Fed communication as informing the change in their expectations.
