The Survey of Market Participants is formulated by the Trading Desk at the Federal Reserve Bank of New York to enhance policymakers' understanding of market expectations on a variety of topics related to the economy, monetary policy and financial markets. The questions involve only topics that are widely discussed in the public domain and never presume any particular policy action. FOMC participants are not involved in the survey's design.

For most questions, median responses across participants, along with the 25th and 75th percentiles, are reported. For questions that ask respondents to give a probability distribution, the average response across participants for each potential outcome is reported. Brief summaries of the comments received in free response form are also provided.

Responses were received from 29 market participants. Except where noted, all 29 participants responded to each question. In some cases, participants may not have provided complete responses (e.g. may not have provided forecasts extending to the same time horizon as requested in the survey). In these instances, the number of respondents who answered all parts of the question is indicated.

Current economic conditions:

(27 responses)

Many respondents indicated that they did not expect material changes to statement language on current economic conditions. Several respondents indicated that they expected the Committee to characterize indicators of economic activity and/or employment as having moderated, with several of these respondents linking the moderation to COVID-19 concerns.

Economic outlook and communication on the expected path of the target federal funds rate: (27 responses)

Most respondents indicated that they did not expect material changes to statement language on the economic outlook or communication on the expected path of the federal funds rate.

Communication on tools other than the target federal funds rate: (28 responses)

Some respondents indicated that they did not expect material changes to statement language on tools other than the target federal funds rate. Some respondents indicated that they expected an advance signal for upcoming decisions regarding the tapering of asset purchases. Several respondents indicated expectations that the signal would include an update on the Committee's judgment of progress toward its goals.

Respondents did not provide significant commentary in this section.

**1c)** What are your expectations for the Chair's press conference?

Some respondents indicated that they expected the Chair to reiterate the distinction between future rate increases and asset purchase tapering, with several of these suggesting he would also note that lifting the target range for the federal funds rate required more stringent criteria to be met. Several respondents indicated that they expected the Chair to discuss the economic impact of the Delta variant or acknowledge that COVID-related risks remain. Several respondents suggested the Chair may provide an advance signal for upcoming decisions on asset purchase tapering. Several respondents suggested that the Chair would indicate that subsequent steps toward an announcement and start of tapering remain conditional on incoming data or the economic impact of the COVID-19 pandemic. Finally, several respondents suggested that the Chair would indicate that labor markets have not yet achieved substantial further progress.

Several respondents indicated that they did not make any material changes to their policy rate expectations. However, several other respondents indicated that they had either brought forward their expectations for the first increase in the target range for the federal funds rate or assigned a greater probability to an earlier rate increase. In explaining changes to their expectations, some respondents noted increases in their inflation projections.

Several respondents indicated that they expected reductions in the pace of asset purchases to occur at each FOMC meeting, while several others indicated that they expected reductions to occur each month.

Many respondents indicated there were no significant changes to their recession probabilities. In describing the factors behind any changes to their responses, some respondents cited COVID-19 developments and/or the spread of the Delta variant of the virus and several cited the persistence of supply chain disruptions.

<sup>\*\*</sup>Previous IMF staff work has suggested that a "global recession" can be characterized as a period during which there is a decline in annual per-capita real global GDP, backed up by a decline or worsening in one or more of the following global macroeconomic indicators: industrial production, trade, capital flows, oil consumption and unemployment.
