The Survey of Market Participants is formulated by the Trading Desk at the Federal Reserve Bank of New York to enhance policymakers' understanding of market expectations on a variety of topics related to the economy, monetary policy and financial markets. The questions involve only topics that are widely discussed in the public domain and never presume any particular policy action. FOMC participants are not involved in the survey's design.

For most questions, median responses across participants, along with the 25th and 75th percentiles, are reported. For questions that ask respondents to give a probability distribution, the average response across participants for each potential outcome is reported. Brief summaries of the comments received in free response form are also provided.

Responses were received from 27 market participants. Except where noted, all 27 participants responded to each question. In some cases, participants may not have provided complete responses (e.g. may not have provided forecasts extending to the same time horizon as requested in the survey). In these instances, the number of respondents who answered all parts of the question is indicated.

Current economic conditions:

Most respondents indicated they expected little or no change.

Many respondents indicated they expected little or no change. Several respondents explicitly indicated that they expected the statement to retain language on taking into account monetary policy lags and economic and financial developments in determining the extent of additional policy firming.

Communication on tools other than the target federal funds rate: (26 responses)

Most respondents indicated they expected little or no change.

1c) What are your expectations for the Chair's press conference?

Many respondents indicated they expected the Chair to note some potential for or express a lean toward further tightening. Some respondents indicated they expected the Chair to note that additional policy firming will depend on incoming data, and several expected the Chair to reiterate the FOMC's commitment to returning inflation to target. Several respondents indicated they expected the Chair to reiterate that rates would remain at an elevated level for an extended period or to push back on near-term rate cuts. Several respondents indicated they expected the Chair to note that the target range is at or near a restrictive level.

If the target range was unchanged at the June meeting, some respondents indicated that they expected the Chair to discuss the rationale for leaving rates

unchanged at the June meeting. Several respondents indicated that in this situation, they expected the Chair to reference factors including assessing monetary policy lags and the cumulative effect of policy tightening, assessing the impact of banking sector stress, or assessing incoming data.

Several respondents indicated they expected the Chair to continue to reference elevated inflation.
