SACED recently acquired a decommissioned school located in rural Rayo Guaras ward, in Saban Grande. SACED's mission is to convert it into a Community Resilience and Recovery Center. SACED projects to develop this center for a dual purpose. First to plan, revitalize and reconstruct part of the school into a safe room/shelter for vulnerable individuals during disaster incidents. SACED has already applied for mitigation funds from FEMA for the shelter/saferoom project. The second purpose (subject of this proposal) is that during non-disaster (blue skies) period the center will serve as a community capacity building, microbusiness incubator center and general community services center. Thanks to a grant by the Puerto Rico Community Foundation, two of SACED Managers are being trained to obtain a local certification to open an incubator for community microenterprises on site. This center will serve the eight municipalities that SACED already serves through its Disaster Case Manager program.

The Corporation for Community and Economic Development of Sabana Grande SACED Inc., Organized under the US federal code 501c (3) as a non-profit organization since 2012 has been providing development tools for the LMI(low to moderate income) population of the southwest area of Puerto Rico, serving an average of 10,000 people per year. Most of those people were served through the drug and substance prevention coalition that is on its fifth year of reducing the underage substance abuse in Sabana Grande. In the aftermath of Hurricane Maria SACED worked with the community to help those in need. SACED office became an oasis for the community. In December 2017 SACED lead the effort to form a Long-Term Recovery Group for Sabana Grande and became a vetted organization in the Voluntary Agencies Leading and Organizing Repair (VALOR) program from FEMA. The program allowed us access to construction materials. On August 4, 2018 FEMA granted SACED a cooperative Agreement to provide Hormigueros, Lajas, Sabana Grande, San German, and Youco. The DCM Program allowed SACED to hire close to 30 professionals to identify the needs for over 4000 individuals. Through the DCM Program we have acute awareness on how Hurricane Maria affected regional jobs and economy. We hope to battle the economic impact of the disaster by empowering people to create their own opportunities through microbusinesses. Just recently, SACED was awarded a USDA Rural Development Grant Through Puerto Rico Community Foundation to establish a Community Microbusiness Incubator.

SACED will create the Community REsilience and Recovery Center for Southwest Puerto RIco in the former school. Two Saced Manager are being trained to develop the Southwest Community Micro Business Incubator. This will be made possible in part thanks to a grant from USDA Rural Development through the Puerto Rico Community Foundation. This grant will provide some technical assistance in the development. It will incubate community start-ps within a responsible and ethical economy framework. Through DCM program SACED has gotten to know the communities it serves, their assets, needs, limitations and opportunities. This puts SACED a step ahead of other incubators. The incubator will connect with partners from the private, public and academic sectors to create a supportive network, evaluate the candidates, provide first generation services: physical or virtual space, shared services and reactive support. It will grow to provide coaching - second generation, and seed money and financing - third generation. THe incubator will have a goal of training 20 individuals from which at least 5 microbusinesses will be incubated. IT will also provide coaching to existing microbusinesses. Since great part of the economic development of the zone is in agriculture, SACED has signed an agreement with NGO Cafiesencia, which have been working with farming communities to improve their product, identify new business opportunities and use conservation practices to enrich their property landscape. The requested funds will be used to:

- Condition room structures for offices, meeting and workshop rooms as well as physical spaces for start-ups.
- Obtain furniture, materials, supplies and equipment computers, printers, software.
- Hire administrative support personnel.
- Hire special contractors with expertise in feasibility studies, business administration, entrepreneurship, specialists in varied industries depending on the startup needs.
- Funds for Seed Money.
- Administration costs like insurance, Permits, utilities and security, WI-Fi will be provided by SACED.

Through this proposal SACED also intends to create a network of contacts to bring potential investors using the Opportunity Zone legislation, Angel Investors, and promote local investment for its startups.

Besides the Incubator, SACED will provide general community services like capacity building and youth empowerment.

Further, US Code Section 1400Z-1(b)(3) Created a special rule for Puerto Rico, making Practically the entire island an opportunity zone. As such, all 8 SACED municipalities have census tracts designated as Opportunity Zones.

To conduct the local performance assessment and comply with the core measures of the CRA and program objectives, SACED will receive support from the Third Mission Institute (IM3, Spanish acronym) at the Carlos Albizu University. The Institute has conducted evaluation and research projects funded by federal and state government agencies on the mainland and in the island. SACED has been working with IM3 for 5 years. In order to conduct the assessment and evaluate the progress of the objectives identified, IM3 team will continue applying an integrative evaluation approach, that combines participatory evaluation model, continuous quality improvement theory, and organizational development theory to catalyze the program goals. This approach fosters a continuous capacity building to enhance effective management, address organizational change, and promote collaborative efforts. Moreover, it actively engages startup members and stakeholders in developing the evaluation process and all stages of its implementation and incorporates structured organizational process for involving coalition leadership into the strategic planning and execution to improve coalition performance and strengthen resources. Internal program evaluations will continue to be conducted to determine overall effectiveness and status. Based on monitoring results, management should be prepared to make adjustments. in the process to monitor and evaluate the performance, qualitative and quantitative data will be collected. Data collection will include documentation review, questionnaires/surveys, checklists and interviews to gather information. The IM3 evaluator will complete these forms and document observations and recommendations. The evaluation results will be discussed with management and staff to continue improving the work. Recurrent and random audits will be conducted to determine if program goals are being met, these audits may range from review of clients progress records to random client surveys.
