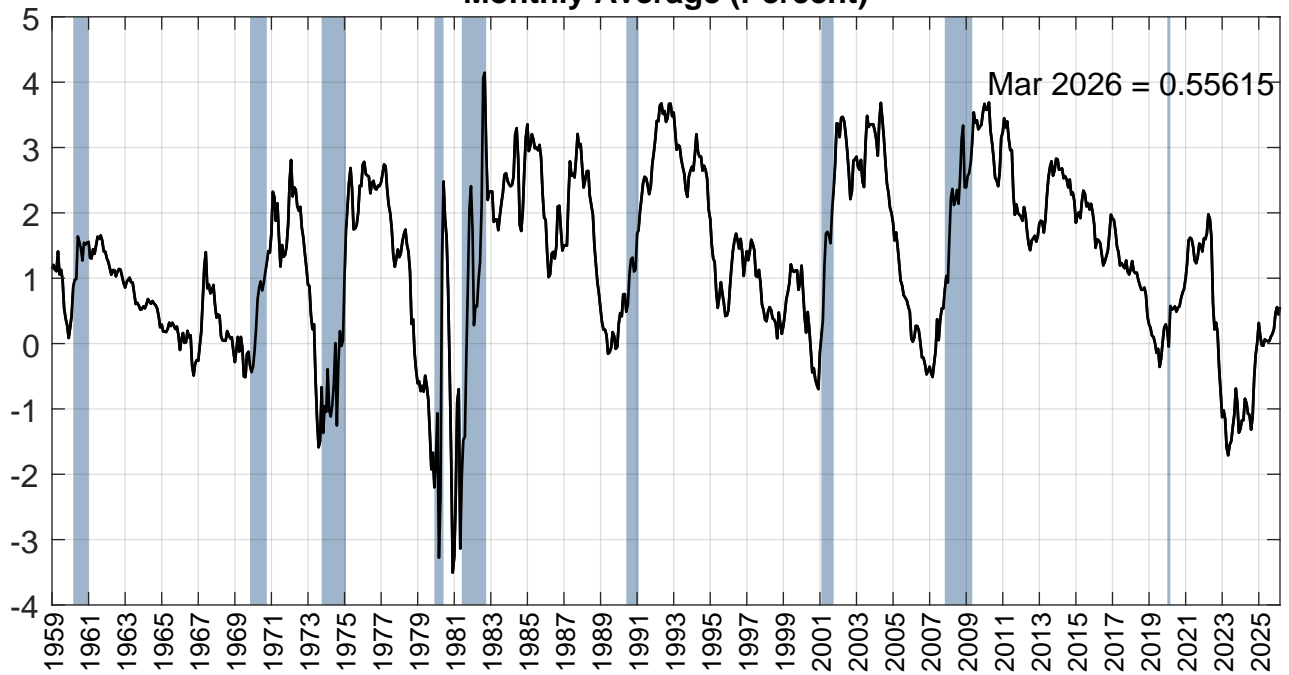
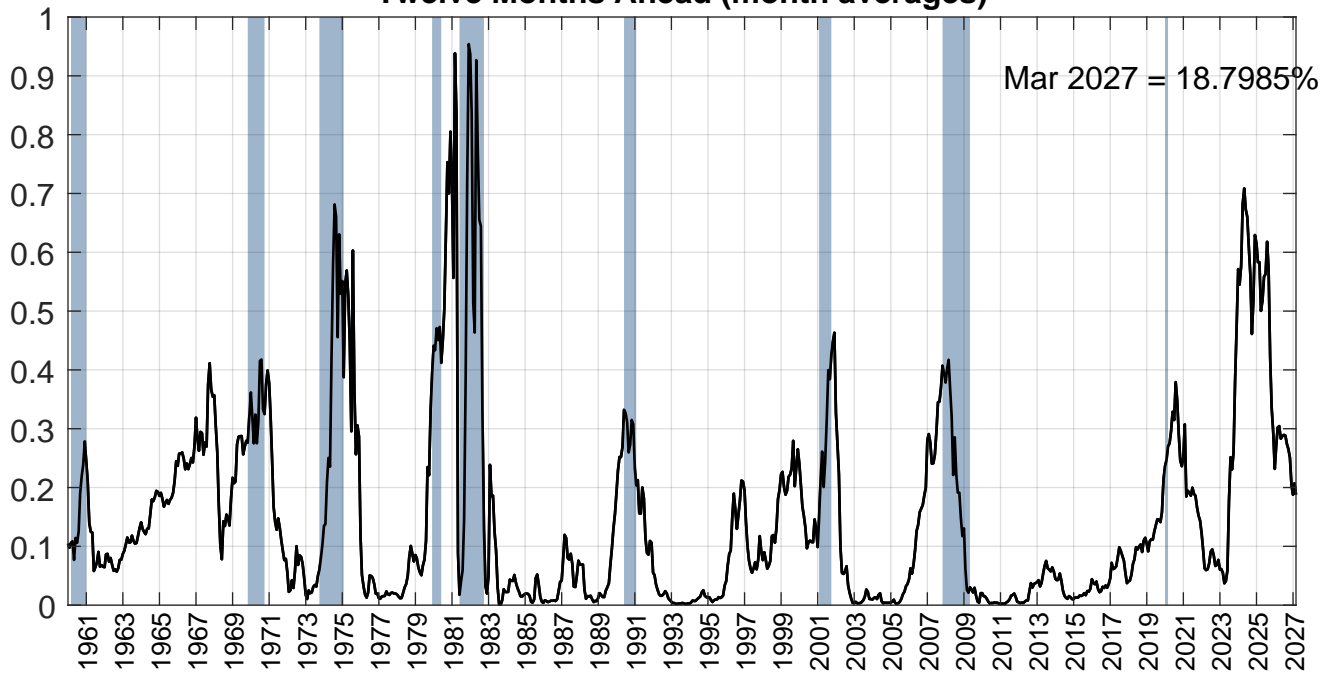


Treasury Spread: 10 yr bond rate-3 month bill rate Monthly Average (Percent)
