Overview of Regional Conditions

- Business activity has picked up somewhat after leveling off in early 2019, though growth remains fairly modest.
- Despite sluggish job growth in most of upstate New York, including Rochester, labor markets have become extremely tight. As a result, wage growth has picked up in the region.
- Businesses in the region report that selling price increases have become more widespread, while input price pressures have begun to ease following strong increases through most of last year.
- With extremely low inventory levels, home prices have generally continued to appreciate throughout the region, though these increases have started to slow recently.





Annual Percent Change in Real GDP




Labor Market Conditions

Unemployment, Participation, and Working Population




Inflation Measures








Regional Consumer Confidence

Overall Consumer Confidence





Indexes of Total Employment, Seasonally Adjusted




Sectors Driving Job Growth in Rochester

Five-Year Change, 2013 to 2018




Exceptionally Tight Labor Markets

Long-Run and Current Unemployment Rates, Seasonally Adjusted




Regional Labor Force Trends

Indexes of Total Labor Force, Seasonally Adjusted




Wage Growth Has Picked Up in the Region


Input and Selling Prices


Regional Home Price Trends

Home Price Index, Seasonally Adjusted




Local Home Price Trends

Backlog of Foreclosures


Share of Mortgages in Foreclosure


State Leading Economic Indexes

Six-Month Forecast of State Growth, December 2018








Utility Patents Granted Per 100K Population, 2000-2015 Average




Rochester Has a Highly Educated Workforce
